ISSUE: It was reported to investigating officers that on December 11, 1992, Darryl Wrisley, a Washington County Deputy Sheriff, made contact at the above person examined's residence, and during that contact, touched the listed victim's bare breasts and attempted to engage in sexual acts against the victim's will using physical force. The investigating officers desired a determination as to whether the statements made by the above person examined were true and accurate.

PRE-TEST INTERVIEW: Kay Earline Williams contacted this examiner and was advised of her rights from the prepared form. At this time, this examiner questioned Ms. Williams as to the occurrences of December 11, 1992. Ms. Williams related to this examiner, in essence, the same information she had given to the investigating officers with no major discrepancies noted. No further relevant information was obtained.

EXAMINATION: Kay Earline Williams was examined on a five-channel instrument.

3) Did Darryl Wrisley ever use physical force, in any way, against you in an attempt to engage in sexual acts with you on December 11, 1992?


Answer: Yes
